

# A BILL

To amend the Internal Revenue Code of 1986 to reduce the tax on beer to its pre-1991 level, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the "Brewers Excise and  
5 Economic Relief Act of 2009".

6 **SEC. 2. REPEAL OF 1990 TAX INCREASE ON BEER.**

7 (a) IN GENERAL.—Paragraph (1) of section 5051(a)  
8 of the Internal Revenue Code of 1986 (relating to imposi-

1 tion and rate of tax on beer) is amended by striking “\$18”  
2 and inserting “\$9”.

3 (b) EFFECTIVE DATE.—The amendment made by  
4 subsection (a) shall take effect on the date of the enact-  
5 ment of this Act.

6 **SEC. 3. TAX RELIEF FOR SMALL BREWERIES.**

7 (a) IN GENERAL.—Subparagraph (A) of section  
8 5051(a)(2) of the Internal Revenue Code of 1986 (relating  
9 to a reduced rate of tax for certain domestic production)  
10 is amended—

11 (1) by striking “\$7” in the heading and insert-  
12 ing “\$3.50”, and

13 (2) by striking “\$7” in the text and inserting  
14 “\$3.50”.

15 (b) EFFECTIVE DATE.—The amendment made by  
16 subsection (a) shall take effect on the date of the enact-  
17 ment of this Act.


